His research and teaching interests are in gender and sexuality, identities and inequalities, particularly in relation to children and young people. Her formation, research and employment has spanned sociology, psychology, education and women's studies. She has researched sex education and teenage pregnancy, lone mothers and lesbian mothers, professional perspectives on sex education and children's views of policy, and has also published on qualitative (discursive) research methods. She is currently on the Sex Education and Gender and Education editorial boards and was a member of the Feminist Review Editorial Collective 1997-2011. (Social work, gender and social exclusion expert and teacher at Universidad Pública de Navarra/Nafarroako Unibertsitate Publikoa – UPNA, Spain)

With a Degree in Sociology and a PhD in Social Work, she is since 2007 lecturer and researcher at the department of Social work at the Public University of Navarre. Her main research themes are related to migration processes, social discrimination, social exclusion and intercultural coexistence. She has led and participated in numerous research projects at local, state and international level. Among them she highlights her participation at the Daphne project "From Street to Home: Investigating how an integrated approach to housing provision and social support can reduce the threat of violence against women", funded by DG Justice of the European Commission.

### Ruth Lewis

She is Associate Professor in the Department of Social Sciences at Northumbria University, UK. Her research focuses on feminist activism and gender-based violence. Recent work examines gender-based violence in universities and activism about it. Her edited book with Sundari Anitha – Gender-Based Violence in University Communities: policies, prevention and educational initiatives - is due out next year, and a special issue of Violence Against Women, edited with Susan Marine, examining activism against GBV in universities, will be published in 2019. She is co-convenor of the Universities Against Gender Based Violence Network as well as the British Sociological Association Gender Study Network. Other work, with Mike Rowe and Clare Wiper, examines online abuse of feminists and, with Elizabeth Sharp, women-only space as a political strategy. Earlier research with Rebecca Dobash, Russell Dobash and Kate Cavanagh examined legal responses to domestic violence, including perpetrators programmes, and a sociological examination of homicide. She has been involved in feminist activism and networks of various kinds, in universities and in communities, which has included helping to run domestic violence organisations, and to organise campaigns, events and conferences, such as the NE Feminist Gathering.






## **Matina Papagiannopoulou**


(Panteion University, Greece)


